Notice #1: Bylaw - Article I - GENERAL MEMBERSHIP, 1.12 Qualifications of Executive Members

Current:

Any person nominated for an Executive position must be either:

- (a) a Member in good standing under Article I, Section 1.2 (a), or

Proposed:

Any person nominate for an Executive position must be a Member in good standing [as defined in](#) Article I, Section 1.2 (a).

Rationale:

Only Members in good standing may be nominated for an Executive position.

Notice #2: Bylaw: Article II - EXECUTIVE BOARD OF DIRECTORS, 2.1 Composition

Current:

The officers and directors of CONFED are one and the same and are the members of the Executive Board of Directors who shall be nominated in accordance with Article I, Section 1.11, above. The Executive Board of Directors of Confederation Hockey Club shall consist of the following positions:

- (a) President;
- (b) Vice-President;
- (c) Director of Hockey Operations;
- (d) Treasurer;
- (e) Secretary;
- (f) Registrar;
- (g) Director at Large;
- (h) Initiation Director;
- (i) Novice Director;
- (j) Atom Director;
- (k) Pee Wee Director;
- (l) Bantam Director;

At any given time, no more than one adult person per registered player may serve on the Executive Board of Directors of CONFED

Proposed:

The officers and directors of CONFED are one and the same and are the members of the Executive Board of Directors who shall be nominated in accordance with Article I, Section 1.11, above. The Executive Board of Directors of Confederation Hockey Club shall consist of the following positions:

- (a) President;
- (b) Vice-President;
- (c) Director of Hockey Operations;

- (d) Treasurer;
- (e) Secretary;
- (f) Registrar;
- (g) Director at Large;
- (h) Initiation Director;
- (i) Novice Director;
- (j) Atom Director;
- (k) Pee Wee Director;
- (l) Bantam Director;
- (m) Ice Allocator

At any given time, no more than one adult person per registered player may serve on the Executive Board of Directors of CONFED

Rationale:

The Ice Allocator should be a nominated position and should be a member of the Executive Board of Directors.

Notice #3: Bylaw: Article II - EXECUTIVE BOARD OF DIRECTORS, 2.11 Duties of the Executive Board of Directors

Proposed: 2.11.13 The Ice Allocator

The Ice Allocator shall be elected for a one (1) year term and shall:

- (a) be responsible for the dissemination of ice assignments to the teams for CONFED;
- (b) conduct and attend meetings regarding ice allocation as required by the Executive Board of Directors;
- (c) submit any written reports to the Executive Board of Directors as required;

Rationale:

The Ice Allocator is a member of the Executive Board of Directors and needs to have the duties outlined within the Bylaws.
